



POST-ACCIDENT REFERENCE

When an MU employee involved in an accident involving a University-owned vehicle operating on a public road that results in (1) a fatality; (2) bodily injury to a person who, as a result of the injury, immediately receives a medical treatment away from the scene of the accident; or (3) one or more motor vehicles incurring disabling damage as a result of the accident, requiring the vehicle(s) to be transported away from the scene by a tow truck or other vehicle.

Rules of Mandatory Post-Accident Testing

- An alcohol test should be administered within two (2) hours following the accident, but in no case more than eight (8) hours after the accident.
- Controlled and illegal substances test must be administered within thirty-two (32) hours following the accident.

* If the employee is not available for any reason, except temporarily leaving the accident scene to obtain assistance in responding to the accident or obtaining necessary emergency medical care, he/she will be deemed to have refused to submit to testing. Do **not** ingest food or drink during the period prior to testing unless the employee must eat or drink based on a medical condition or medical orders.

Testing Steps

1. Contact HRS informing the department of the incident at 703-284-1680.
2. Contact testing site nearest to you (*see reverse side)
