Voluntary Benefits

Marymount University Retirement Savings Plans



Voya Financial serves as the administrator for Marymount's 403(b) Defined Contribution and non-qualified (NQ) retirement plans. These flexible plans allow employees to set aside money either on a pre-tax or Roth basis [403(b) only] via payroll deduction up to the IRS permitted limits which can be invested in a wide array of low cost investment options.

Employees that participate in the 403(b) are eligible to receive a 100% match up to 6% of eligible pay. Marymount will make a 2% non-elective contribution to eligible employees immediately after hire date with their first paycheck. A 4-year vesting schedule applies where an employee is 100% vested (will receive 100% of all employer contributions) after four (4) years of employment. Vesting schedule is 25% each year. Employees are always 100% vested in the contributions they add to their account.

METRO TRANSPORTATION

Marymount has partnered with the Washington Metropolitan Area Transit Authority (WMATA) to offer employees transit and parking benefits using **Metro SmarTrip** cards. The amount you designate for this benefit will be deducted on a pre-tax basis from your semi-monthly paycheck of up to \$315 per month for transit and \$315 for the parking.



Pets Best is a program designed to provide coverage for your dog/cat that fits your needs and budget. The plan can cover accidents, accident related diagnostic exams, wellness visits, and illness.

Legal Resources protects you and your family from paying the high cost of attorney fees associated with everyday life events.
